



REGULATION FOR THE REGISTRATION TO THE EVENT

DEFINITIONS

- **Event:** the event that will be held on a virtual platform over two days, from 1st to 2nd July 2021, and broadcasted online on the following link <https://www.centrorestaurovenaria.it/young-professionals-forum-2021>
- **Expert:** each of the professionals in the field of Cultural Heritage who will play the role of Expert Professional for the related activity Experts meeting;
- **Candidates:** anyone who has correctly filled in and submitted the registration form to the Event;
- **Event Participants or Participants:** anyone who has paid the Event Membership Fee;
- **Promoter:** Fondazione Centro Conservazione e Restauro dei Beni Culturali La Venaria Reale (<https://www.centrorestaurovenaria.it/>).

Art. 1 – Registration for the Event

1.1 Event Subscribers may:

- Participate in the two days of the Young Professionals Forum (1-2 July 2021);
- Consult and download free of charge the proceedings of the Young Professionals Forum 2021;
- Participate in the selection for the related activity Experts Meeting (28-30 June 2021).

Art. 2 - Registration procedure

2.1 Applicants must complete the registration form (Google Form) available at

<https://forms.gle/nHicsy2hkpbclZBW9>

- After the completion and submission of the registration form, the Candidate will receive, at the e-mail address indicated at the time of registration, an e-mail containing the details to pay the registration fee;
- The payment transfer must be made no later than 3 days from the sending of the email containing the details to pay the registration fee. A copy of the wire transfer receipt

must be sent to the e-mail address youproforum@centrorestaurovenaria.it no later than 3 days after payment.

2.2 Upon receipt of the bank transfer receipt, the Promoter will send, to the e-mail address indicated at the time of registration, the relevant invoice together with the instructions for participation in the Event.

2.3 If you do not receive the emails referred to in points 2.1 or 2.2, you can contact the Promoter Body at the e-mail address youproforum@centrorestaurovenaria.it

2.4 If the Event Member does not participate in the Event, for reasons not attributable to the Promoter, the Promoter will not be required to pay any refund.

Art. 3 – Experts Meeting

3.1 Candidates interested in attending the Experts Meeting must fill in the appropriate fields of the registration form (Google form).

3.2 The Promoter Body, after the registration phase, will select, among the Candidates, the Participants who will have the right to a digital meeting with the Experts.

3.3 The selection criteria will be based on the content entered during the compilation of the Google Form, the order of time of registration and based on the availability of each individual Expert identified.

3.4 The selected Participants will receive an e-mail confirming the selection, containing the instructions for participation in the Experts Meeting (date, time, link to the virtual call). Unsuccessful candidates will not receive any email.

Art. 4 – Changes to the Event programming

4.1 The sponsoring body reserves the right to modify unilaterally the programming of the Event.

4.2 In the case of the Event cannot be held or must be postponed due to unforeseeable circumstances, force majeure or events in any case not attributable to the Promoter, the Promoter shall not be held liable for any loss or damage suffered by the Participants.

4.3 In the event mentioned above, the Promoter reserves the right to retain the entire registration fee and use it for the organization of a new event.

4.4 In any case, the Promoter does not assume any responsibility and will therefore not be obliged to recognise any right to reimbursement:

- For any problem of access, impediment or malfunction related to technical or computer tools, telephone line or internet connection, hardware or software components or any other

cause not attributable to the Promoter Body that may result in the non-attachment or participation in the Event by the candidates;

- For any errors in the communication of information and/or material necessary for the registration/participation of candidates. This includes any communications made at a time and/or in a manner other than those described in this regulation or in the registration pages of the Event, as well as incomplete information and/or material communications, corrupt or not received for causes not attributable to the Promoter;
- For any problems in sending/receiving e-mail for reasons not attributable to it.

Please Note: We inform you that the event that will take place on 1st and 2nd July 2021 will be recorded and stored in all its contents (also chat), by the Promoter Body. Registration by the participants and disclosure of the same shall be prohibited.
