### By joining the YPC you automatically agree to this regulation and our Terms of Use.

#### How to use the Community spaces:

Users use YPC spaces to find inspiration, share information, discuss ideas and build social relationships.

The Young Professionals Community is a public feature of the Young Professionals Forum, a project carried out by the Fondazione Centro Conservazione e Restauro "La Venaria Reale" where users can interact with each other.

Users who join the YPC who are under 16 years of age must be accompanied by a tutor in the use of our channels.

# In order for the YPC to remain a safe and tolerant place, the user undertakes to comply with the following rules:

- 1. Respect the **privacy of other users**. Do not share private information or information that may be identified as personal in the YPC public spaces, and do not produce spam.

- 4. Comments are a great way to ask VS questions about an article or post. **The comment space should not be used for activities explicitly prohibited by the Community Regulation** or spam.
- 5. To publish video/image/text content (not comment on existing content) the following procedure must be followed:

  - b. In agreement with the community team, an ad hoc content will be created for the community that will focus on your project
  - c. The schedule of the content output will be agreed with the community team
